The undersigned, pursuant to Chapter 10 of Title 13.1 of the Code of Virginia, states as follows:

1. The Election Center will be incorporated in the Commonwealth of Virginia as a non-stock, non-profit corporation.
2. The membership of The Election Center is to include those state and local election officials of all fifty states and the four territories of the United States of America. An "election official" is defined by The Election Center as any person or persons who is/are the administrator(s) of the registration or electoral process at the state or local level.

The Election Center provides to its membership the following services: a computerized bulletin board which provides information to the membership on legislative and litigation activities involving federal, state and local electoral issues; a professional staff which monitors and researches election law legislation and serves as a conduit information exchange between legislators and election officials; a bi-monthly publication on election legislative and litigation information; and, conferences and study sessions on current issues in the election area on an as-needed and timely basis.

3. The directors of The Election Center shall be appointed by its President for a period of one year, to be reappointed on an annual basis, from among the membership in good standing of the organization.
4. The Election Center is initially registered with an office address located at: 1312 Chetworth Court, Alexandria, Virginia 22314, with the registered office located in the City of Alexandria, Virginia.
5. The name of the initial registered agent of The Election Center, whose business office is identical with the above registered office, is Carol D. Garner. The registered agent is an individual who is a resident of Virginia and an initial director of the corporation.

VIRGINIA CORPORATION LAW PROVIDES THAT IF ANY DOMESTIC CORPORATION FAILS TO FILE AN ANNUAL REPORT WITH THE STATE CORPORATION COMMISSION BEFORE SEPTEMBER 1 OF THE YEAR IT IS DUE, ITS CORPORATE EXISTENCE SHALL AUTOMATICALLY CEASE AS OF SEPTEMBER 1. SEE SECTIONS 13.1-752 (STOCK CORPORATIONS) AND 13.1-914 (NONSTOCK CORPORATIONS) OF THE CODE OF VIRGINIA. 

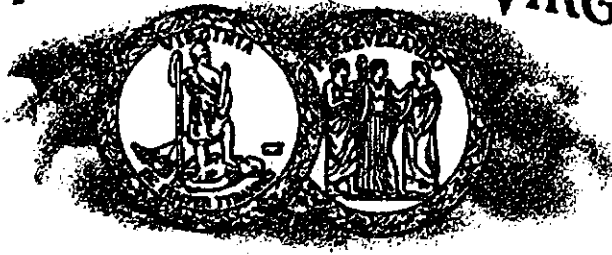
